At the request of the latter, the Public Policy Loan project with the French Development Agency - AFD of 65 million euros) is to support the development and implementation of a **sustainable bioeconomy** public policy. This will allow the diversification of the **production** matrix, ensure welfare and strengthen the **conservation of biodiversity**

**A3.** Analysis of the elements gathered and provide the necessary deliverables for AFD to make an informed choice, and in particular, an initial note facilitating AFD's choice of project to be financed, a presentation sheet of the selected project, a note of surprise on the Public Policy Matrix and the feasibility study report
